

# Get Bonus for the review

Welcome, dear members!

This article is about reviews on our community. The purpose of the reviews is to make the good actions of the SuperCashBox widely known.

Reviews are an important and very powerful tool for promoting and expanding any project. The more positive feedback from our members on the Internet, the more people will join the SuperCashBox and the greater the growth rate of the community will be. Which will increase the income from participation, and in that, no doubt, every member has interest.

Every review left by members on the Internet is valuable to the community and deserves a reward. Therefore, the SuperCashBox is ready to pay members **bonuses for reviews** posted on social networks.

*Write the reviews, post them on the Internet and get  
**Bonuses for reviews!***

## Bonuses

- **Budget** of the Promotion is 300 tet per week, which is distributed among all members who have sent their review.  
At the same time, the criteria are taken into account:
  - type of review;
  - content of the review;
  - spread of the review.
- **For the first review** the bonus is **doubled**.

## Additional benefits

By posting reviews about SuperCashBox on the regular basis in your social media, you will receive not only a bonus for a review, but also new registrations that will bring you additional income, thanks to the [Affiliate program](#) operating in the community

There is also the ["Matrix Bonus"](#), which gives in addition to affiliate rewards, an additional bonus of 15 tet for every third invitee.

And the reviews will help you win in the ["SuperPartners"](#) game, which is valid members that invite partners on an ongoing basis and gives you the opportunity to receive a prize of up to 200 tet every month.

# Conditions

1. **Promotion is valid** on a permanent basis.
2. **Every active member** of the community can take part in the promotion .
  - a. To participate, fill in the [APPLICATION](#). (Use browser translation)
3. **Types of reviews:**
  - a. text review;
  - b. photo review;
  - c. video review.
4. **Where to post the review:**
  - a. On your personal social media pages;
  - b. In groups where you are the administrator;
  - c. In forums and blogs devoted to the topic of investment and earnings on the Internet.
5. **Bonuses** for reviews are calculated based on the **promotion budget of 300 tet** per week and are distributed among all members who fulfilled the conditions of the promotion according to the criteria and the number of points accumulated by the review.

6. **Bonus accrual:**
  - a. **Bonuses are accrued once per week** to the Prepayment balance in the PA of the member, after summing up the results and the number of points for review.
  - b. **Reporting week** for reviews begins on Monday and ends on Sunday. Review should be sent no later than 12 p.m Moscow time on Sunday. Reviews received later will be included in the next Reporting week.
  - c. **The bonus for the review** is accredited next week in the period from Thursday to Sunday.
7. **Rules for reviews:**
  - a. **Review requirements:** All reviews must contain information about Passive Income Advertising Strategies. Read more in the section **“Reviews Requirements”**.
  - b. **How often can you send reviews?** Only one review can be accepted from one member **no more than once every 2 weeks**.
  - c. **Amount in the review.** If the review refers to withdrawal, replenishment, reinvestment, then the amount spoken about must be **at least 10 tet**.
  - d. **Limitation period** for a financial transaction must be no more than 14 days from the date of this operation and up to the day the review is sent.
  - e. Similar reviews with repetitive themes will receive fewer points. For more information, check **“Recommendations for writing a review”**.
  - f. **Maximum placement.** You can place your review on any number of internet sites. The more placements, the more points you get.
  - g. **Affiliate link.** All reviews **must** contain your affiliate link. Your affiliate link to register in the project:  
*<https://tinyurl.com/skopilka/registration/?p=yournickname>*.

Create permanent links with TinyUrl, so that all clicks on your links will go to the freshest mirror of the site, more in the article "[Instructions for creating a permanent affiliate link](#)". (Use browser translation)

**Pay attention!** For members who have additional Personal Accounts (PA) with the Passive Income Advertising Strategies (PIAS), use affiliate link only from the main Personal Account, because according to the terms of the "Personal Account with PIAS for everyone" there is no affiliate program in PA with PIAS. Members with registered Kid's PA cannot take part in the promotion, because according to the terms of the "[Children's Personal Accounts](#)" (Use browser translation) promotion it is forbidden to register new members using Kid's PA affiliate link until the members are 18 years old.

- h. **Link Shortener.** To keep you
- i. r social networks from getting blocked for using affiliate links, use a link shortener service. For more information, see the article "[Bypassing Blocking on Social Networks](#)". (Use browser translation)
- j. **Reviews are not deleted.** You should not delete reviews from your YouTube channels and social media, as each subsequent review will be checked to see if the previous review has been forum.
- k. **Using someone else's reviews is not allowed.** The review must be written by you personally. You may not copy reviews posted on the site, in chat, on members' personal pages, in groups or forums.

## Calculation of bonuses for reviews

Community reviews posted online and submitted through the [Form](#) earn a certain number of points, which **will then be exchanged for tet**.

The number of points for a review is formed by three criteria:

1. **Type of review:** text reviews, vide reviews (with or without camera), photo reviews. Each type of review has its own value in points.
2. **Content of the review:** Information that review contains, as it is presented. It can be just facts like date and amount of the transaction or a more detailed overview of the community, describing your impressions of membership. Grammar and style, informative level and emotional tone (Lively, energetic, positive, inspiring) also taken into account.
3. **Review distribution.** Each review must be posted in one or more social networks, forums, blogs. The more friends and subscribers you have in total, the more points you will get. And in the case of posting a review on forums and blogs, the attendance of these resources will be taken into account, i.e. the more visits to the resource where you posted the review the more points you will receive.

### 1 criterion. Points for the type of review.

- Video review - **15 points**;
- Photo review - **10 points**;
- Text review - **5 points**.

## 2 criterion. Points for the content of the review.

- Excellent review - **10 points**;
- Good review - **5 points**.

When evaluating the content of the review (for the three types of reviews) the following criteria will be taken into account:

	<b>Excellent review</b>	<b>Good review</b>
General structure	logically coherent text, hat its own conclusions	logically coherent text
Content	detailed, informative review, resonated statement of your position	detailed, informative review
Emotionality	positive, very bright, emotional, motivational review	positive, motivational review
Originality and creativity	original review and informed conclusions about the project from personal experience, creative approach in presenting and providing review	personal impression about the project

## 3 criteria. Points for review distribution.

Points for review distribution are based on the number of friends or followers on your social medias:

- More than 10 000 people - **15 points**;
- From 1 000 to 10 000 people - **10 points**;
- From 50 to 1 000 people - **5 points**.

When calculating this criterion, the platform on which the review were posted is also considered.

The chart shows a list of sites for publishing the review, as well as the system for calculating the total number of friends and followers that will be counted for the criterion.

<b>Where to review was posted</b>	<b>Number of subscribers/friends taken into account</b>
Personal pages in social media with a number of friends <b>from 50 people</b> .	Equals the number of friends of the page
Personal and public groups in social media with <b>50 or more subscribers</b> . This must be your own personal group or a public group	Equal to the number of subscribers to the group.

where you are listed as an administrator.	
Personal YouTube-channels with the number of subscribers <b>from 1,000 people</b> .	Equals the number of subscribers to the channel / 10 (divided by 10)
TikTok	Equal to the number of subscribers to the social media
Private Telegram chats with the number of members <b>from 50 people</b>	Equal to the number of chat participants
Blogs devoted to the topic of Internet investments	Equals to the average number of users who visited the blog <b>per week</b> / 100 (divided by 100)
Forums devoted to the topic of Internet investments	Equals to the average number of users who visited the forum <b>per week</b> / 1000 (divided by 1000)

If the forum or site does not have a counter of visits, then this parameter can be tracked through a service for analyzing sites <https://a.pr-cy.ru/>.

Let's look at the example. The member sent 3 links in the application:

- 1st link to the published review in VK, where the member has 900 friends;
- 2nd link to the review in Personal Telegram chat with 80 members;
- 3rd link to the review, published on the forum, which has 100 thousand visitors per week.

To determine the number of points for 3rd criterion, you must first count the total number of friends, members and visitors on all 3 resources:

$900+80+100000/1000=1080$  people.

For the 3rd criterion, 10 points will be awarded for review distribution.

**Attention!** If you are posting reviews on **Facebook**, along with a link to your review, you need to send a screenshot of the main page which shows your name and number of friends. You need a screenshot that shows how many friends you have in that social media, because Facebook has limited ability to see that number.

Reviews can be posted on your page in social media, as well as on other Internet sites, there are no limitations on that matter.

***The more points you accumulate,  
the higher reward you will get!***

## Double reward

If this is the first time you leave a review of one of the types (text review, vide review, photo review), the amount of bonuses received for placing the review will be **increased by 2 times!**

## Budget and value of points.

- **The weekly budget** for rewarding all reviews is **300 tet**.
- **Points for all reviews** of all members are summed up at the end of the week and then distributed proportionally to the budget.
- **The price per point** in tet is calculated using the formula: *Weekly budget divided by total amount of points*. For example, all members have accumulated 500 points. Divide  $300/500=0,6$  tet per point.

### Let's look at example:

- A member posted a video review on his social media page where he has 150 friends.
- Review will be evaluated according to 3 criteria.
  - 1st criterion: 15 points for the type of review, since it's a video review.
  - 2nd criterion: the content of the review is - excellent, so it is 10 points.
  - 3rd criterion: for the review distribution will be awarded 5 points.In total we got 30 points.  
Multiply member's points by the price of the point,  $30 \times 0,6 = 18$  tet - that's how much the member will get as the reward for the posted review.

The amount of bonus for review isn't locked, it all depends on how many members in a particular week take part in the promotion and how many points in total were accumulated. This rating system takes into account the number of friends/subscribers, content, and type of review.

## Review requirements

**A general requirement for all reviews:** each review must contain information about Passive Income Advertising Strategies (PIAS).

[Promotional PIS](#) (Use browser translation) are available to new members in the community. Advertising Strategies is a great way to invite new members to build their passive income in SuperCashBox by starting participation without contributing their own funds.

So regardless of the topic and the type of review, you **should definitely mention the PIAS** in your reviews. You can use the suggested options in this article below in the "Additional Materials" section.

**Requirements for each type of review.** In order for your reviews to be accepted and well rewarded, it is important that they meet all of the requirements described below:

- **Video reviews** can be recorded with or without a camera, just showing the screen. Video reviews must meet the following requirements:
  - quality not less than 1280x720 pixels;
  - sound should be good, without background noises, all the words clear;
  - video must not contain music and sound effects;

- duration of the video is recommended 3-5 minutes, the maximum is 15 minutes.
- **Photo reviews** can be either with money or with purchases for SuperCashBox payouts. Photo reviews must meet the following requirements:
  - Photo must necessarily show the member with the purchase or money.
  - There must be the name or the SuperCashBox logo on the photo. They must be on the photo itself, not added in photo editor programs.
  - **Important!** Photo must be accompanied by a text review, for the content of which you will receive 10 or 5 points.
- **Text reviews must meet the following requirements:**
  - review must contain **at least** 5 sentences;
  - necessarily all reviews must have screenshots of payments/contributions from the wallet or Personal Account, which confirm the fact that you have received a payment and made a contribution;
  - It is recommended, but not mandatory, to send a personal photo of 250x250 pixels.

**The best reviews will be evaluated to the maximum** and placed on SuperCashBox resources with your affiliate links, which will attract new members to your structure.

## No points awarded for reviews

- For reviews posted on profile pages that have less than 50 friends or a hidden friend list.
- For reviews posted on pages and platforms with limited-access. All reviews must be in the public domain, so that they can be viewed by clicking on the link without having to add the member as a friend or register on the site.
- For reviews that don't allow you to understand what it is about, in which project you received a payout or created a program. The review must contain a minimum of information with the name of the community and the event that happened.
- For reviews of the same type. For example, you left a review with some text and next week copied the old review, changing the screenshot or transaction information.
- For reviews posted in advertising groups of social network or in groups maintained (administered by the group) not by the member who sent the review;
- For reviews posted on sites not related to the topic of investing or making money on the Internet.
- For reviews that have been sent in other promotions, contests and events.
- For reviews that have been previously awarded under the "Get Bonus for Review" promotion.

## Recommendations for writing a review

**Topics for a review** can be:

- **About the financial transaction** in Personal Account for a total amount of 10 tet or more (such reviews must be confirmed by screenshots from your e-wallet with the transaction number) :
  - replenishment + payment for contributions;
  - receiving payout + reinvestment;
  - receiving payout + withdrawal to the wallet.
- **Personal impression** of participation in the project, promotions and events.
- **Detailed review of the project:** about the opportunities and benefits that SuperCashBox provides to its members.
- **Review about important community news.**
- **Review about the book** “Money creation technology”.
- **Review about the TetaCoin** - SuperCahBox token.
- **Review about the game** “SuperPartners”.
- **Review about the promotion** “Get Bonus for Review”.

The main purpose of reviews is to attract new people to the community. Real reviews from current members are one of the best tools for this. To attract an audience, reviews need to be interesting and varied. That’s why the following rule applies in the promotion:

- **Identical reviews** with repetitive themes receive **fewer points**.

Reviews on the same subjects, sent from one member after another, will receive less points. The point reductions will occur exponentially:

1. For a second review on the same topic, the number of points for the review will be divided by 2;
2. Next reviews with the same type will not be accepted.

If more than **2 months** have passed since the previous review on this topic, the bonus **will not be reduced**.

**Recommendations** for increasing the amount of the Bonus for a review and Affiliate Bonuses:

- **Write high quality and emotional reviews.** The more compelling the review is, the more it will attract the attention of potential newcomers, which means more registrations, which will bring you additional income - affiliate program reward.
- **Increase the number of friends and followers** on your social media page. The more friends and followers you have, the more points you will get. Also, these new friends will see your reviews on SuperCashBox and may become members, who will give you affiliate rewards of 10% from the member’s.
- **Post review additionally** in groups and publishers, forums and blogs with high traffic - the more visits the resource where you posted the review has, the more points you will get.
